Inviting Nominations for the DPVN PTA 2025-26

Dear Parents,
Greetings of the day!

We are delighted to announce the formation of the Parent Teacher Association (PTA) for the Academic Year 2025-26.

This initiative will provide an opportunity to exchange views, work together and to enhance mutual trust and confidence. The aims and objectives of DPVN PTA shall be:

- to encourage fellowship among parents and the school community.
- to achieve a mutual understanding of goals and challenges in educating children.
- to ensure that our children receive the best education that we can possibly give them to foster the best physical, intellectual and mental health.
- to assist the school with activities where parent involvement is required.
- to ensure precise understanding of the education policies and programs of school and support the school committee in communication and action of policies, strategies and other activities.
- to ensure that parents are receiving all the information they need regarding educational happening at school.
- to help raise funds for the school and the Parents Teacher Association (for social connect programmes) in-consultation with the Principal and Board of Management.

The Parent Teachers association will however not get involved in individual complaints, day to day running of the school, curriculum formulation, appointment of teachers, carrying out activities without consultation with Principal and/or Board of Management, portraying the school, its staff, the Board of Management, and learners in a negative manner.

Eligibility criteria for candidature:

1. All parents whose ward/(s) are studying in school are inevitably the members of the PTA. Such participation shall be non-political and non-religious.
2. Parents who have the time and are willing to shoulder the responsibilities of a conscientious Managing Committee Member.
3. Parents, who submit their "Application for Membership form of PTA" along with membership fee Rs.50/- will be eligible to contest and vote in the elections. The amount collected from the parents shall be kept in the PTA Fund.

Kindly note The PTA is a non-profit making body and all funds raised or held by the PTA are solely used for meeting the objectives of the PTA. All expenditures of the PTA fund need to be approved by the Managing Committee through a majority vote.

Constitution of Executive Committee

1. At least one member belonging to the Scheduled Castes, Scheduled Tribes or Backward Class of Citizens shall be appointed by rotation so that every category gets representation, in every year.
2. At least 50% of the members shall be women.
3. The tenure of a PTA would be for one (1) year. Any parent who has become the office bearer, cannot hold that position for next 5 years.

The last date for filling nominations is 23rd June, 2025.

The final election process will be held on 27th June, 2025. The details will be shared soon.

Parents desirous of contesting elections are requested to collect nomination forms from the school office and submit the same as per the following schedule:

- (a) Issue of nomination forms 20th June 2025.
- (b) Submission of completed nomination forms by 23rd June 2025
- (c) Election of Class Representatives (one from each grade from Grades I to XII) 25th June 2025.
- (d) Election of PTA Executive Committee Members to be informed later.

We look forward to welcome you for the election of our Class Representatives.
